Mengikut seksyen 44 Akta Perancang Bandar 1995, seseorang yang memperoleh atau menyebabkan pemerolehan suatu perakuan pendaftaran, perakuan pendaftaran sementara atau permit dengan membuat atau menyebabkan dibuat atau menghasilkan atau menyebabkan dihasilkan suatu akaun, perakuan, permohonan atau representasi palsu atau tipuan melakukan suatu kesalahan di bawah seksyen ini dan boleh, apabila disabitkan didenda **tidak melebihi sepuluh ribu ringgit** atau **dipenjarakan selama tempoh tidak melebihi dua tahun atau keduanya** dan dalam hal kesalahan yang berterusan, didenda tidak melebihi satu ribu ringgit bagi tiap-tiap hari atau sebahagian daripada sehari selama kesalahan itu berterusan selepas sabitan.

*According to section 44 of the Town Planners Act 1995, a person who procures or causes the procurement of a certificate of registration by making or causing to be made or producing or causing to be produced, a false or fraudulent declaration, certificate, application or representation shall be guilty of an offence under this section and shall, on conviction be liable to a fine **not exceeding ten thousand ringgit** or to imprisonment for a term not exceeding two years or to both and in the case of a continuing offence, be liable to a fine not exceeding one thousand ringgit for every day or part of a day during which the offence continues after conviction.*
